## 2025 Wyoming United Methodist Church Fall Craft Show

Wyoming United Methodist Church is hosting its annual Fall Craft Show on Saturday, November 8<sup>th</sup> 2025 at our church facility at 216 Wyoming Mill Road in Dover, Delaware, featuring many different handmade crafts, **free** admission and parking, no stairs, and handicap accessible restrooms. The Fall Craft Show hours will run from 9:00 a.m. until 2:00 p.m.

This is a juried show of hand-crafted items. In the interest of maintaining high standards at this Craft Show all prospective exhibitors must submit at least two clear, quality photographs or colored digital copies with one of a complete display including product(s). The photographs are used to judge your crafts and to help create the floor plan. You may only display and sell the types of hand-crafted items shown in your photos sent with your application. Spaces are \$40 with a limit of two side-by-side spaces. The fee includes one 8-foot table and two chairs.

Applications will be reviewed, and you will be notified of acceptance or non-acceptance into the show via email and/or phone call. Please note, while we do have the support of the Church administration, they are not involved with the planning of this event. Any questions or concerns regarding your participation in the Craft Show should be referred to the Craft Show Chairperson at <a href="https://www.wyomingchurchcraftshowchair@gmail.com">wyomingchurchcraftshowchair@gmail.com</a>.

No unlicensed items with team/company logos will be allowed. Any items containing a trademark logo or even freehand logos/team colors require permission and/or licensing arrangements with the team/company in question before being sold even at craft fairs/events. Selling such items creates the risk of a trademark infringement lawsuit that could extend to the sponsor of the craft fair/event. Accordingly, no such items can be included in the show without prior written proof of permission or license agreement. Any vendor exhibiting unacceptable items will be asked to remove them or be dismissed from the show. This includes but is not limited to, NFL and Disney items.

All tables are to be attractively covered to the floor on all exposed sides with fabric coverings only. Plastic is not acceptable. No packing cartons are to be visible. No tent framing allowed. You must maintain your display until the show's end at 2:00 p.m.

All displays must be set up by 8:30 a.m. on Saturday. After setting up, please move vehicles to the far side of the parking lot to allow customers to utilize close spaces. The Craft Show Team reserves the right to assign another crafter your space after 8:30 a.m.

Set up times: Friday 4:30 - 7:00 p.m. and Saturday 7:00 - 8:30 a.m. Crafters are responsible for cleaning their space after the show. Recycling and trash bins are located in the parking lot.

Electrical outlets are limited. Please request an outlet only if your display requires one. The cost is an additional \$10.00 per application. Crafters must provide their own heavy duty extension cords.

All spaces are assigned by the Craft Show Team. A great deal of time and thought is spent placing crafters. No changes will be made the day of the show.

Cancellation Policy: Prior to April 5th, if the Craft Show Team can fill the spot a full refund will be sent. No refunds after April 6<sup>th</sup>.

The Spring Craft Show will be May 9<sup>th</sup> 2026. Applications will be available December 1<sup>st</sup>.
